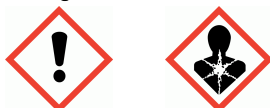

## 5. Fire-fighting measures

### Extinguishing media

**Suitable extinguishing media** The product is combustible. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

**Unsuitable extinguishing media** Do not use water jet as an extinguisher, as this will spread the fire.

### Special hazards arising from the substance or mixture

**Specific hazards** Containers can burst violently or explode when heated, due to excessive pressure build-up. Vapors may be ignited by a spark, a hot surface or an ember. Vapors may form explosive mixtures with air. Fire-water run-off in sewers may create fire or explosion hazard.

### Advice for firefighters
